Prerequisites

1-60 credits within the subject of Sport Science or equivalent. English B or equivalent.

Objectives

Upon completion of the course, the student is expected to:

- Describe the way sport is organised at international level;
- Problematize cultural similarities and differences relating to sport as a global and local practice;
- Critically reflect upon sustainable development in the sport science arena.

Content

The course contains the following components:

- The culture and ideals of the Swedish sports movement;
- Sport, organisation and society international perspectives;
- Sport and sustainable development on a global scale.

Type of Instruction

Teaching comprises lectures, supervisions, group work and seminars.

Examination

The course is assessed with the grades A, B, C, D, E, Fx or F.

The grade A constitutes the highest grade on the scale and the remaining grades follow in descending order where the grade E is the lowest grade on the scale that will result in a pass. The grade F means that the student's performance is assessed as fail (i.e. received the grade F). Fx is not a grade and is only used when a student is allowed to complement her/his examination. Students who have not passed (i.e. received the grade of F) at the regular examination will be offered a new examination shortly after the regular examination.

Course learning outcomes are evaluated during participation in two seminars worth a total of 4 credits (2 x 2 credits), and an individual written report totalling 3.5 credits.

All assignments are assessed using grades A-F. Grade E is required for all assignments to receive the lowest final grade of E. To achieve the final grade C for the course, the lowest grade of C is required for each assignment. To achieve the final grade A for the course, the lowest grade of A is required for each assignment.

Course Evaluation

A course evaluation will be conducted during the course or close to its completion. The results and analyses from the course evaluation will be provided to the students who have completed the course, and those who will participate when the course is next given.

The summary will be presented to the applicable departmental body and programme board, and will be archived by the departmental course coordinator. The course evaluation is anonymous.
