Prerequisites

A minimum of 30 ECTS credits in Political science, or 30 ECTS credits in other related social science subjects.

Objectives

On successful completion of the module, the student should be able to:

- Explicate the EU-institutions and the decision making procedures
- Account for the EU's key policy areas
- Explain how the EU's political system of separation of power and democracy can be discussed
- Illuminate the EU's political system from a historical perspective
- Conduct a political analyses of EU-politics.

Content

The course gives a broad overview of European Union Politics and its political system. It includes the origin and the historical development of the EU, the EU-institutions and decision procedures, key policy areas, separation of power between the EU and the member states, and the EU's foreign relations, including enlargement and neighborhood policy. Finally, contemporary issues of the European Union are discussed.

Type of Instruction

The teaching methods consist of lectures and seminars.

Examination

The course is assessed with the grades A, B, C, D, E, Fx or F.

The grade A constitutes the highest grade on the scale and the remaining grades follow in descending order where the grade E is the lowest grade on the scale that will result in a pass. The grade F means that the student's performance is assessed as fail. To receive pass (E or higher) the student should reach all the course objectives. Examination consists of two seminars (20% of the total course grade) and one written test in the class room (80% of the total course grade). The final course grade is decided based on all exams on a 100-point scale, in which E is between 50-59 points, D 60-69 points, C 70-79 points, B 80-89 points and an A over 90 points.

Course Evaluation

A course evaluation will be carried out at the end of the course in accordance with the guidelines of Linnaeus University. The result of the evaluation will be reported back to students and will also be communicated the next time the course is held.

The course cannot be included in a degree along with the following course/courses of which the content fully, or partly, corresponds to the content of this course:1SK198 and 1SK143.
