Course Objective

After finishing this course, the student:

- has acquired basic understanding of the multifaceted intersections between religion and SDG-related societal, political and economic issues:
- is able to analyze a basic interaction between religion, theology, academic disciplines and societal actors in other to develop a deeper understanding of and better (practical) responses to SDGs;
- has acquired and has demonstrated, in working groups, writing and presenting, basic academic skills, such as asking proper academic questions, critically appraising information, and effectively presenting data and academic arguments;
- has become through dialogic education more aware of the assumptions she or he lives by when it comes to the relation religion and sustainable development.

Course Content

This course introduces the topic of religion and sustainable development. Since 2015 the Sustainable Development Goals (SDGs) have become the umbrella to address key challenges of our times, for example climate change, poverty, inequality, health and migration. In many of these challenges religion plays, or can play, a significant role, e.g. health care in Africa, the worldviews people live by or concepts of hope thematized in religious traditions. This course explores this kind of interactions between religion and SDGs. The SDGs are categorized in the sub-themes planet, people, prosperity and partnership. Special attention is given

to religion and planet. The course is interdisciplinary and societal partners are involved, e.g. religious grassroots communities, faith-based organisations, religious institutions, businesses and governments.

Additional Information Teaching Methods

The course exists of lectures (3 hours a week) and working groups (3 hours a week). The student is allowed to miss one class with reason, further attendance is compulsory.

Method of Assessment

The assessment will consist of:

- 1. Dialogical learning: Participation in (online) classroom and preparation through pre-class online submission of questions evaluated on consistency of submission and quality (35%)
- 2. At the beginning of the course a selected number of about 4

assignments are presented. These assignments in the field of religion and sustainability are developed in interaction with involved parties like religions, faith-based organization, companies and cities. The assignments expressed in an academic paper/report are presented and formally submitted after corrections based on the judgement by party involved and university teacher. The interaction with the parties and the executive summary of the report (community service learning) is 30% of the overall assessment. The academic aspect, the paper is 35% of the assessment.
