Course Objective

After finishing this course, the student:

- will have knowledge of ethics of the world religions in the field of environmental ethics.
- will understand and be able to apply their knowledge of general ethics to religious ethics and will also be able to define the limitations of traditional ethics in religious communities (Aim: general ethics).
- will understand religious ethical approaches to ethical theories of conservation, preservation, guardianship, holism, deep ecology, and justice, as well as the ethical use of nature in ritual performance (Aim: environmental ethics).
- the student is able to critically evaluate various religious approaches to nature, discovering both evident and hidden issues within the debate. S/he is able to adapt her/his application of religious ethics to ecology (Aim: contextual orientation).
- the student is able to thoughtfully participate in discussion regarding religious ethics and ecology.

Course Content

This class considers various ethical aspects of humanity's spiritual and religious interaction with non-human nature as well as the environment's impact on the human experience of religion and spirituality. It broaches the topic from religious studies perspectives, but enters into dialogue with ethical specialists from other disciplines and practitioners from the field. What, if anything, can religious studies contribute to our understanding of environmental ethics? Thinking outside of the box is encouraged and world religions are investigated.

Additional Information Teaching Methods

This class is a reading/lecture course. The method consists of lectures, classroom discussion, weekly workgroups, the preparation of an individual project, presentation of individual projects. and video content. A final project will be completed at the end of the course.

Method of Assessment

Project, classroom discussion, and group participation (60%);
